

# The Norwegian Maritime Directorates Initial and annual fees for delegated NIS ships

All NIS- registered ships over 500 grt, with the exception of some high-speed passenger ships, are delegated to an approved classification society

## EXAMPLES OF INITIAL FEES

CARGO SHIPS OF 500 grt and more - with the exception of standby- and supply ships:

Basic amount of NOK 12 000,- plus the following, additional, tonnage fee:

The first 5 000 net:	NOK 5,- pr. ton
The following 5 000 net:	NOK 4,- pr. ton
The following 20 000 net:	NOK 3,- pr. ton
The following 40 000 net:	NOK 2,- pr. ton
Ships of more than 70 000 net:	an additional NOK 1,- pr. ton past 70 000 net
Calculated fee is to multiplied by 1, 1719	

## PASSENGER SHIPS:

Basic amount of NOK 5 000,- plus an additional tonnage fee of NOK 0.50,- per net

Calculated fee is to multiplied by 1, 1719

## CURRENT, ANNUAL FEES

- Additional to the initial fee

Please note that for delegated NIS ships over 500 grt inspection/ supervision fee is paid to the classification society in which the ship is classed. These fees are not regulated by the NMD.

### THE ANNUAL FEE

Applies to cargo ships, passenger vessels registered in Norway.

### THE BASIC FEE

Applies to ships subject to mandatory certification and all other ships where mandatory certificates of acceptance have been issued according to the NMD's legislation.

Supervision fees are paid for those ships subject to regular inspections performed by the NMD and not an approved classification society.

For tonnage above 70 000 net	20 000 + 1,00 pr.net	NOK 20 000 + 2,00 pr. net

Calculated fee is to multiplied by 1,3416

Please note that the Norwegian Maritime Directorate is currently working on re-adjusting their initial fees to be more cost based.
